Preamble:

- 1) The financial powers vested with various office heads for Tea and Refreshment expenses were prescribed the resolution of 66th BoD meeting of HESCOM. Accordingly, order was issued by order No.: HESCOM/GM(A)/AO(A)/AAO(A)/66TH/BM/CR-12/14-15/CYS-1889, Dated: 27.08.2015.
- 2) It is observed that, there is increase of price of consumables by over 122.8% between 2016 to 2021 as per All India Consumer Price Index, which indicates the necessity to enhance the limits prescribed in the financial power delegated to the Officers in the said order. In this backdrop, it is proposed by the various offices to enhance the limits of expenditure towards Tea and Refreshment.
- 3) This office Note approved by Managing Director, HESCOM, Dated: 29.09.2021 subject to ensuing BoD ratification.
