**Preamble:**

1) As per the amendment to the KTPP act, and to serve the public/consumers in time it is felt necessary that, the Officers should be vested with more financial powers to overcome the difficulty in procurement of materials & timely execution and completion of the work in situations such as arranging power supply, restoration of power supply and attending to line breakdowns.

The subject was placed before the Board of Director of HESCOM at its 95<sup>th</sup> Board Meeting held on 16.02.2021 where in the Board approved the amendment of Manual of Delegation of Financial Powers and directed to issue necessary order only after conforming that these changes are exactly at par with what is previously in BESCO.
