



- Sub:** Enhancement of Compensation payable in case of Fatal/ Non Fatal Electricla Accidents to Non-departmental payment of Solatium to owners off animals that die of electrocution.

Preamble:

- 1) The rates of Solatium payable to Human-life in case of Fatal and ex-gratia in case of disablements causes due to Non-Fatal electrical accidents, in respect of Non-Departmental persons and also ex-gratia in cases animals, Solatium rates to owners of animals that die of electrocution needed to be revised in view of cost of living & also since the rates fixed was long back. The issue was placed before KPTCL Board of Directors meeting, on 6th September 2017 for a decision. As such it was resolved to revise the rates proposed vide Resolution No.106/11 dated: 06.09.2017 to be effective from the date of MMR meeting ie; 07th August, 2017. Hence KPTCL Order issued vide No.: KPTCL/B7/2476/95-96 Vol 1 Bengaluru, Dated: 09.11.2017.
- 2) In the KPTCL Order issued vide No.: KPTCL/B7/2476/95-96 Vol 1 Bengaluru, Dated: 09.11.2017 in Sl. No.: 3 and 4 regarding loss of crop/ property/ house hold equipment's should be assessed by the concerned necessary authority and Jurisdictional Chief Engineer (Elec.)/ Superintending Engineer (Elec.) shall approve for payment of compensation. In the said order the amount of compensation for loss of crop/ property/ house hold equipment's were not mentioned.
- 3) The subjects were placed before the Board of Director of HESCOM at its 96th Board Meeting held on 18.06.2021, where in the Board approved the delegating the power for giving "Compensation payable in case of loss of crop/ property/ house hold equipment's due to electrocution" to respective authorities as proposed.



All payments towards the above accidents shall be made subject to following conditions:-

1. The cause of accident should be certified by the concerned Electrical Inspectorate authority.
2. Loss of Crop/ Property/ House hold equipment etc., should be assessed by the concerned necessary authority.
3. The Jurisdictional Chief Engineer(Elel.)/ Superintending Engineer(Elec.) Shall approve for payment of Compensation.
4. An undertaking from the claimant stating that the payment made is full and final settlement of the cases shall be obtained.

Note: For Compensation payable in other cases, KPTCL Order vide reference-1 shall be followed.
