**Preamble:**

- 1) The financial powers vested with various office heads for Tea and Refreshment expenses were prescribed the resolution of 66<sup>th</sup> BoD meeting of HESCOM. Accordingly, order was issued by order No.: HESCOM/GM(A)/AO(A)/AAO(A)/66<sup>TH</sup>/BM/CR-12/14-15/CYS-1889, Dated: 27.08.2015.
- 2) It is observed that, there is increase of price of consumables by over 122.8% between 2016 to 2021 as per All India Consumer Price Index, which indicates the necessity to enhance the limits prescribed in the financial power delegated to the Officers in the said order. In this backdrop, it is proposed by the various offices to enhance the limits of expenditure towards Tea and Refreshment.
- 3) Hence, in view of the above, amendment order was issued in respect of Tea and Refreshment expenses vide order No.: HCO-07/C121/2018-19, Dated: 01.10.2021 subject to ensuing BoD ratification.
- 4) The proposal for ratification was placed before the 98<sup>th</sup> BoD Meeting held on 28.10.2021, in BoD meeting, Board accorded its approval to ratify the action taken by MD, HESCOM for amendment issued to Manual of Delegation of Financial Powers in respect to Tea and Refreshment expenses vide order No. HCO-07/C121/2018-19, Dated: 01.10.2021 vide subject No.: 98/18.
