Preamble:

- 1) The following provisions were made in Section-4, clause-(e), Sub clause-(i) and(ii) of the KTPP Act 1999(substituted by act 21 of 2001 w.e.f. 25-08-2001).
 - 4. Exceptions to applicability. The Provisions of Chapter II shall not apply to procurement of goods and services:
 - "(i) In case of construction works of all types the value of which does not exceed rupees five lakhs.
 - (ii) in case of goods or Service other than construction works the value of which does not exceed rupees one lakh".
- The following Amendment is issued vide GOK Gazette Notification Dated: 27-04-2020 to Section-4, clause-(e), Sub clause-(i) of the KTPP Act 1999.
 - 2. Amendment of section 4.- In the Karnataka Transparency in public procurements act,1999(Karnataka Acct 29 of 2000) in section 4, in clause(e).
 - (i) in sub-clause (i) for the words "construction works and consultancy services" the words "goods and services including construction works and consultancy services" substituted, and
 - (ii) sub-clause (ii) shall be omitted.
- 3) Hence, in accordance with the above amendment to the KTPP act, and to serve the public/consumers in time it is felt necessary to adopt the KTPP (Amendment) Act 2020 and, the MD HESCOM be vested with financial powers upto Rs 5.00 Lakhs in respect of award of Works, Procurement of Materials and availing services by LOCAL enquiry/Limited Tender to overcome the difficulty in procurement of minor materials & timely execution and completion of the urgent nature of works in situations such as arranging power supply, restoration of power supply and attending to line breakdowns.
