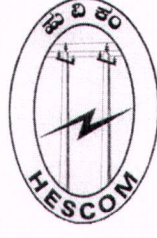

Read: 79th BoD Resolution Subject No.79/24.

Preamble:

1. The Chief Engineer(Elec.), Hubballi Zone, Hubballi has submitted proposal to create a new O and M Sub-division at Rattihalli duly bifurcating from the existing O and M Sub-Division, Hirekerur.
2. The existing O and M Sub-Division, Hirekerur having vast area, more number of installations, longer length of HT and LT lines, more number of DTCs as a result of which, it is difficult to monitor power supply, maintenance of the electrical infrastructure and revenue collection. This has resulted into poor performance of the Sub-division on various parameters of O & M and Revenue collection. Therefore, it is felt necessary to create new Sub-Division at Rattihalli.
3. In this context, Agenda was placed in 79th BoD meeting held on 16.09.2017 with updated parameters, the matter was debated in detail and resolved as follows;

RESOLVED THAT for the reasons explained in the proposal, following be and is hereby approved;
