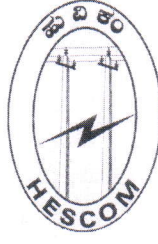

Subject : Creation of New O & M City Sub-Division-4 at Navanagar, Hubballi duly bifurcating from the existing O & M Sub-Division-3, Hubballi.

Read : 78th BoD Resolution Subject No.: 78/25.

Preamble:

1. The Chief Engineer(Ele.), Hubballi Zone, Hubballi has submitted proposal to create a new O and M City Sub-Division-4 at Navanagar, Hubballi duly bifurcating from the existing O and M City Sub-Division-3, Hubballi.
2. The existing O and M City Sub-Division-3, Hubballi having vast area, more number of installations, longer length of HT and LT lines, more number of DTCs as a result of which, it is difficult to monitor power supply, maintenance of the electrical infrastructure and revenue collection. This has resulted into poor performance of the Sub-Division on various parameters of O & M and Revenue collection. Therefore, it is felt necessary to create new City Sub-Division-4 at Navanagar, Hubballi.
3. In this regard, the detailed Agenda was placed before the 78th BoD held on 19th May, 2017 vide Subject No. 78/25.
4. The matter was debated; Approving the proposal, Board passed the following resolutions:

“RESOLVED THAT for the reasons explained in the proposal, approval be and is hereby accorded to create new O & M City Sub-Division-4 at Hubballi duly bifurcating it from O and M City Sub-Division-3, Hubballi.

5. **FURTHER RESOLVED THAT**, subject to above, General Manager(A & HRD) be and is hereby authorized to issue necessary orders accordingly and to incur additional employee cost of Rs. 40.52 Lakhs per annum as proposed be and hereby approved.
