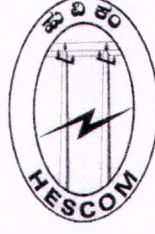

1. The Chief Engineer (Elec.), Hubballi Zone, Hubballi has submitted proposal to create a new O and M Section at Hebballi duly bifurcating from existing O and M Sections in O and M Rural Sub-Division, Dharwad.
2. The existing O and M Section is geographically very vast. In Order to improve the overall efficiency in the existing O and M Sections, as well as O & M Sub-Division and, with a view to avoid inconvenience to the consumers covered in the jurisdiction, it is felt necessary to create O and M Section at Hebballi duly bifurcating from the existing O and M Sections in Rural Sub-Division, Dharwad.




