Preamble:

- 1. The Chief Engineer (Ele.), Hubblali Zone has submitted a proposal to create new O and M Sections at O and M Rural Division, Dharwad duly bifurcating from the existing O and M Sections.
- 2. HESCOM is having 281 Section Offices spread over 7 Districts. In this some of the Sections are having vast area, more number of installations, longer length of HT and LT lines, more number of DTCs as a result of which, it is difficult for such Section Officers to monitor power supply, maintenance of the electrical infrastructure and revenue collection. This has resulted into poor performance of these sections on various parameters of O & M and revenue collection. Therefore, it is proposed to create new O and M Sections comprehensively in HESCOM.
- 3. In this context, Agenda was placed in 74th BOD meeting held on 03.09.2016 with updated parameters, the matter was debated in detail and resolved that;
 - A) Formation of new O and M Section at Garag(SO-2) duly bifurcating the existing O and M Rural Section, Dharwad(SO-1).
 - B) Conversion of existing Non-accounting Section Alnavar as Accounting Section.
- 4. And further resolved that, "consequent to the above, redeployment/ creation of staff as with additional Employee cost of Rs. 7.71 Lakhs per annum to the proposed Sections O and M Section, Garag and Rs. 4.61 Lakhs per annum to the Proposed Accounting Section at Alnavar be and hereby approved.
