Read : 75th BoD Resolution No. 75/23.

Preamble:

1. The Chief Engineer(Ele.), Hubballi Zone, Hubballi has submitted a proposal to create a new O and M Division at Honnavar with stores duly bifurcating from existing O and M Division, Karwar.
2. The existing O and M Division, Karwar is geographically very vast. Moreover, Karwar Division jurisdiction covers with forest. In order to improve the overall efficiency in the existing O and M Division, Karwar as well as O and M Sub-divisions and, with a view to avoid inconvenience to the consumers covered in the jurisdiction, it is felt necessary to create an O and M Division at Honnavar with stores duly bifurcating from existing O and M Division, Karwar.
3. The detailed Agenda was placed before the 75th BoD held on 05th November, 2016 vide subject no. 75/23.
4. The matter was debated; Approving the proposal, Board passed the following resolutions:
"RESOLVED THAT for the reasons explained, approval be and is hereby accorded for formation of New O and M Division at Honnavar with stores duly bifurcating Karwar O and M Division."
5. And **FURTHER RESOLVED THAT**, subject to above, General Manager(A & HRD) be and is hereby authorized to issue necessary orders accordingly and to incur additional employee cost of Rs. 220.11 Lakhs per annum as proposed be and hereby approved."
