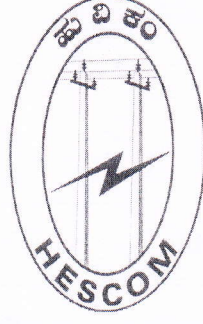

Preamble:

1. The financial powers vested with various office heads for shifting the post of Group-D employees under intimation to Corporate Office were prescribed as per the resolution of 15th Board of Directors meeting during 2005. Accordingly, order was issued vide order no. HESCOM/HC-12/15TH BOD/05/07-08, dated 20.12.2007.
2. As per the HESCOM Manual of Delegation of Powers, in respect of establishment matters Sl. No. 8 MD/CEEs/SEEs/EEEs are authorized full powers to Shifting the post of Group-D employees under intimation to the Corporate Office.
3. In this regard, the proposal was placed before the 70th BOD of HESCOM held on 29.09.2015 at Corporate Office, Hubballi for authorization to Managing Director for shifting of Group A, B, C and D posts within HESCOM.
4. In 70th BOD of HESCOM, the Board passed the following resolution vide Subject no.70/13;
"MD, HESCOM be and is hereby authorized to shift posts belonging to Group-A, Group-B, Group-C and Group-D of HESCOM within the jurisdiction of HESCOM as deemed necessary".
