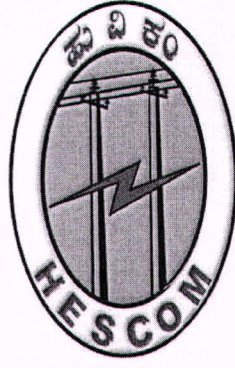

The HUBLI ELECTRICITY SUPPLY COMPANY LIMITED is pleased to insert a new Regulation and Note in Regulation-8 under Chapter: I of the HUBLI ELECTRICITY SUPPLY COMPANY LIMITED RECRUITMENT AND PROMOTION REGULATIONS, EMPLOYEES[PROBATION] REGULATIONS AND EMPLOYEES[SENIORITY] REGULATIONS', as here under;

1. TITLE AND COMMENCEMENT:

- a. These Regulations shall be called the HUBLI ELECTRICITY SUPPLY COMPANY LIMITED RECRUITMENT AND PROMOTION REGULATIONS, EMPLOYEES[PROBATION] REGULATIONS AND EMPLOYEES[SENIORITY] REGULATIONS', 2016.
- b. These shall come into force with immediate effect.

2. INSERTION TO REGULATION-8: DISQUALIFICATION FOR APPOINTMENT UNDER CHAPTER-I OF The HUBLI ELECTRICITY SUPPLY COMPANY LIMITED RECRUITMENT AND PROMOTION REGULATIONS, EMPLOYEES[PROBATION] REGULATIONS AND EMPLOYEES[SENIORITY] REGULATIONS;

The following shall be inserted as new Regulation and Note in Regulation-8: DISQUALIFICATION FOR APPOINTMENT, under Chapter-I of The HUBLI ELECTRICITY SUPPLY COMPANY LIMITED RECRUITMENT AND PROMOTION REGULATIONS, EMPLOYEES[PROBATION] REGULATIONS AND EMPLOYEES[SENIORITY] REGULATIONS' AS HERE UNDER;

"8[5]: Notwithstanding anything contained in the Regulations no candidate shall be eligible for selection in respect of Group 'A' & 'B' posts unless he/ she qualifies in a test in Kannada Language.

[P.T.O.]

This test shall comprise of one paper carrying maximum of 150 marks. For qualifying in this paper a candidate must score minimum of 50 marks. The standard of this paper shall be that of first language Kannada at SSLC Level.

Note: Provided that candidates who have passed the SSLC examination or any examination declared as equivalent to by the State Government or any examination higher than SSLC examinations in which Kannada is the main Language or Second Language or an optional subject[but not one of the subjects in a composite paper] or if they have studied and passed in Kannada Medium are exempted from passing the compulsory Kannada Language Test.”
