Sub: Amendment to Manual of Delegation of Financial Powers – 2012 in respect of sanction of power supply to Industries and other consumers.

Preamble:

- 1) The Under Secretary, Energy Department has issued a detailed procedure to be followed and to be adopted for arranging power supply to HT and EHT installations. In this regard Proposal for Amendment to delegation of powers of HESCOM 2007 and 2012 were placed before the 96th BOD meeting of HESCOM held on 18.06.2021. The subject was discussed and approved vide subject No.: 96/14. Accordingly, order was issued for amendment of delegation of power vide order No.: HCO-07/ C121/ 2018-19, Dated:22.07.2021 as below;

- 2) As per Conditions of Supply of Electricity of KERC reg **12.04 POWERS OF SANCTION AND RENEWAL OF TEMPORARY POWER SUPPLY;**

(i) Sanction of temporary power supply

Officer of the Licensee who are empowered to sanction permanent power supply are also authorized to sanction temporary power supply to the same extent for a period required by the Applicants irrespective of whether it is lighting, power, temporary touring Cinemas etc, subject to observance of Rules and Conditions laid down in this Clause.

- 3) In the above Order Dated: 22.07.2021 the nomenclature was mentioned as **“Sanction of power supply to industries and other consumers”**. Hence as per KERC Conditions of Supply of Electricity it needs to be amended as **“Sanction of permanent and temporary power supply to industries and other consumers”**.
