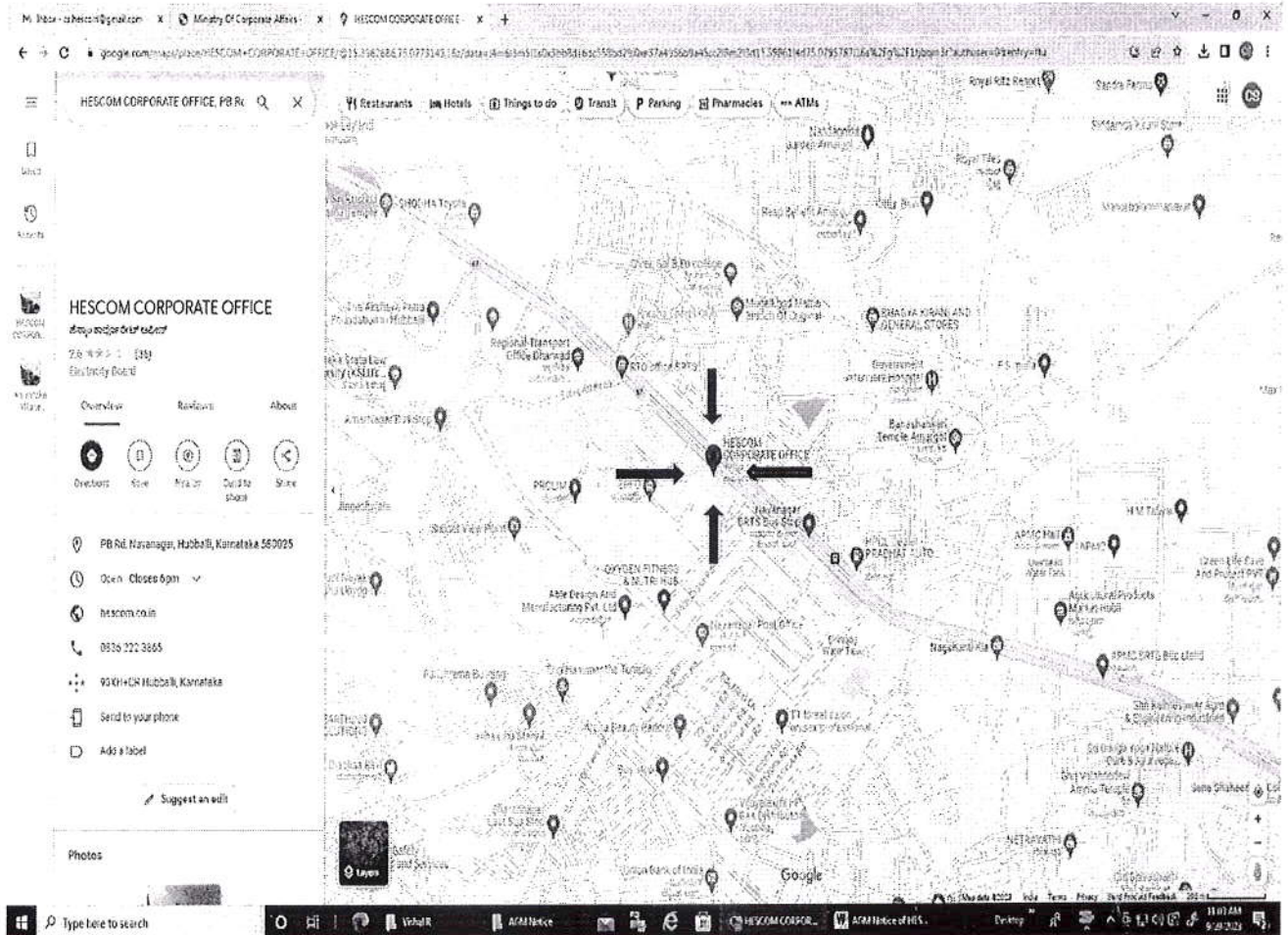
GENERAL GUIDELINES FOR VC PARTICIPATION:
