Heard Sri K.G.Raghavan, learned Senior Counsel appearing on behalf of the petitioners.

In this writ petition, the petitioners have sought for direction, declaring Regulation 11 (iv) of the KERC (Terms and Conditions for Open Access) Regulation, 2004, substituted by KERC (Terms and Conditions for Open Access) (Fourth Amendment) Regulations, 2017 produced Annexure-A3 to the writ petition, as ultra virus. In that view of the matter, the writ petition requires detailed consideration.

Issue emergent notice to the respondents.
