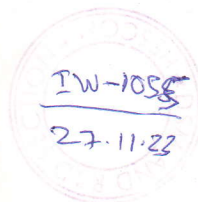
The Indian Oil Corporation Ltd vide letter cited under reference has sought separate electrical connections under LT with the requisitioned load ranging from 30 kW to 120 kW for installation of EV Charging Stations exempting from installing separate transformers at their Petrol Bunks. It has further requested to direct the DISCOMs to execute the total job on deposit contribution basis so as to expedite the process of installing EV charging stations in the State, informing that they are unable to install transformers in their premises as they have to comply with the distance norms of PESO (Petroleum and Explosives Safety Organization).

The Commission has examined the proposal and noted that at present there is no specific provision in the CoS for arranging power supply to EV chargers and

Distribution Licensees are arranging power supply /additional power supply to such installations wherein the applicant/Consumer has to execute the infrastructure works under self-execution if the requisitioned load is 35 KW or more. Considering the request, the Commission has decided to remove the difficulties duly invoking the provision under the clause 46.00 of the CoS, for removal of difficulties.
