

1) The CGRF O & M Circle, HESCOM, Belagavi Passed the Order Vide No.
BGM/CGRF/SEE/DCA/AAO/SA-2/2021-22/6766-68 Dated : 16.02.2022 , as
under.

1. The Appeal Petition dated 12.10.2021 filed by the complainant
before CGRF, O & M Circle, HESCOM, Belagavi against the
Supplemental Claims dated 28.06.2021 in hereby dismissed.
2. The complainant is hereby directed to make payment of
supplemental claims amount to Rs. 28,71,777/- pertaining to
RR.No.MSBA-36373 and RR.No.MSBA-36429 at the office of
the Respondent within 15 days, failing which the respondent
can take action as per HESCOM rules as per Revenue Recovery
Act.

2) Skypark Apartment Owner's Association addressed a letter Dated
24.02.2022 to CGRF, Belagavi and requested as under.

- a) Accept an initial sum amounting to Rs. 7.00 Lakhs which we
have been able to raise through some difficult.
- b) Allow us an extension of time limit so that we may make the
reminder of the payment in eight installments, on the first
day of each month.
- c) To kindly with hold the imposition of interest till the revised
payment schedule is completed.



- 3) The Billing Claim of Rs. 28,71,777/- is due to an error while issuing bills by the O & M Sub Division to the consumer and is not an arrears accumulated by the consumer.
- 4) The Regulation on Page No. 112 & 113 of Condition of Supply 4.22– Disputes in the bill Clause (e) under sub clause (3) says
“ May allow installment option.”


Under the circumstances explained in the above preamble. The CGRF, HESCOM Belagavi, passes the following addendum in addition to the Judgement passed by the CGRF HESCOM, Belagavi Vide Order No. BGM/CGRF/SEE/DCA/AAO/SA-2/2021-22/6766-68 Dated. 16.02.2022.

ORDER

The Consumer is permitted to pay total bill amount of Rs. 28,71,777/- in parts as below.

- a) The Consumer is permitted to pay Rs. 7,00,000/- (Rupee Seven Lakhs) as initial payment within 5th Mar 2022.
- b) The Consumer is permitted to pay the remaining bill amount of Rs. 21,71,777/- in Five equal Installments along with their monthly regular bills commencing from April-2022.
- c) If consumer fails to pay the bill as per above conditions, the Assistant Executive Engineer(Ele.) O & M Sub Division No.2 Belagavi is at liberty to take action as per HESCOM rules/norms, and as per Revenue Recovery Dues Act.
