Venue: Industrial Training Center, Karwar Road, HESCOM, Hubballi.

Training timing: 10.30 A.M. to 5.30 P.M.

In view to contain the possible spread Covid-19 virus, all the employees should have been vaccinated. Other precautionary measures mentioned below should be adhered strictly, as mentioned below:

1. Self monitoring of health by all and reporting it to the staff of ITC.
2. Physical distancing of at least 6 feet to be followed in the premises of ITC.
