Sub: Execution of power purchase agreement for SRTPV projects for FY20-reg.

With reference to the above subject, it is to inform that, the Commission had issued the Generic Tariff Order in respect of Solar power projects on 18.05.2018 for determining the tariff for the period from 01.04.2018 to 31.03.2019. In order to determine the generic tariff for the next control period ie from 01.04.2019 to 31.03.2020, the Commission has issued a discussion paper on 06.02.2019 and the generic tariff is yet to be finalised.

In view of the above, the Commission has received many representations/ letters from Solar Roof Top Developers and SRTPV consumers requesting for extending the existing tariff of solar roof top projects, as per the existing order until a new tariff is determined.
