Directions for implementing provisions under Central Electricity Authority (Installation and Operation of Meters) Regulations, 2006 and its amendments thereof -Reg

It has come to the notice of the Commission that, generating companies and licensees (Transmission/Distribution) are not implementing the following provisions specified under Central Electricity Authority (Installation and Operation of Meters) Regulations, 2006 and its amendments thereof effectively, which is leading to many unnecessary litigations with respect to energy accounting:

a) Installation of 'Standby Meter' in (i) High Voltage(HV) side of Generator Transformers,
 (ii) High Voltage side of all Station Auxiliary Transformers and 'Main Meters and Check Meters' on all outgoing feeders including bus sectionalizer or tie line between two

The clause 3(4) of Central Electricity Authority (Technical Standards for Construction of Electrical Plants and Electric Lines) Regulations, 2010 including its latest version issued in 2022, mandates that the Electrical Plants and Electric Lines shall be designed to comply with requirements stipulated in other Central Electricity Authority Regulations as well, framed under the Electricity Act 2003. However, non-implementation of above said provisions under Central Electricity Authority (Installation and Operation of Meters) Regulations, 2006 and its amendments thereof concludes that some Electrical Plants are being commissioned and commissioning certificates are issued by the concerned licensees without proper implementation of these Regulations.

In view of the above, the Commission hereby directs KPTCL and ESCOMs that, the above said provisions under Central Electricity Authority (Installation and Operation of Meters) Regulations, 2006 and its amendments thereof are strictly implemented in all the existing Electricity Plants on priority basis and in upcoming Electricity Plants before its commissioning, subject to other specific timelines fixed by the Commission in its Orders. Provided further that the generating companies or licensees may install meters at additional locations in their systems depending upon the requirement in line with clause 7(1) of these Regulations.
