The new transformers which are being used for works are now being tested by TA & QC wing at the premises of manufacturer only in spite of Energy department circular and T.O. letter vide ref (2), which is clear violation of govt. directions.

Hence, here after all the new transformers which are being used for works either purchased by HESCOM or by applicants for self-execution bases are to be mandatorily tested in the testing benches of the respective divisions or at any nearest divisions where transformer testing bench are established duly collecting the testing fee of Rs. 250/- per transformer from prospective consumers. The DTR's which are brought for testing are to be tested duly verifying the invoices, applicants name and purpose for which it is being required with respect to sanction letter from competent authority. The Executive Engineer (El) MT Divisions shall monitor the above works on daily basis, so that testing shall not create inconvenience to consumers. The tested transformers shall be sealed after testing. A soft copy of tested distribution transformers shall be mailed to General Manager (Tech), Superintending Engineer (IT & MT) and respective Executive Engineer (El) (O & M Divisions) on daily basis. The TA & QC wing shall not test the distribution transformers w.e.f. **01.02.2020** and all the seals left with TA & QC wing shall be returned to store.
