The suggestions are made by the Government of India for improving the "Ease of doing the business" in the states. There is an assessment frame work for ranking the States in "Ease of doing the business" based on the implementation of suggestions made by the GoI. Karnataka Udyog Mitra, the nodal agency for Karnataka State has requested to adopt the suggestions made by the Government of India. Further in order to maintain the proper data base of the user and for revenue management, the proof of identity of the user is very essential.

For the implementation of action points suggested by the Government of India and Energy department of Gok, the following instruction are to be followed for collecting the number of mandatory documents required for obtaining the electricity connection in line with KERC regulations for arranging power supply to the HT/LT industrial consumers.

- Proof of identity of the user. (Adhar card, EPIC, Driving Licence, Passport, Pan card etc.,)
- Proof of ownership of the premises or proof of occupancy with consent of owner, in the absence of such consent, indemnity bond as per Annex-8 of KERC regulations.
- Authorization documents in case of firm or Company (Partnership deed in the case of a partnership firm, or Memorandum of Association & Article of Association and Certificate of incorporation, in the case of a limited company/Limited liability Partnership firm)

All the Superintending Engineer's O & M Circles/ EE's of O & M Divisions are requested to adhere to the above mentioned instructions scrupulously.
