The suggestions are made by the Government of India for improving the "Ease of doing the business" in the states. There is an assessment frame work for ranking the states in "Ease of doing the business" based on the implantation of suggestions made by the GoI. Karnataka Udyog Mitra, the nodal agency for Karnataka State has requested to adopt the suggestion made by the Government of India to ensure that the Karnataka State is ranked on high in the comparison.

Adverting to the above and to expedite the existing procedure for obtaining new electricity connection, it has been decided to revise the timelines for release of charged electricity connection for industrial use from the date of application for electrical connection as follows.

- Connections including CEIG approval (if required) up to 200 KVA to be provided within seven days, where no RoW is required.
- Connections including CEIG approval (if required) up to 200 KVA to be provided within fifteen days, where RoW is required.

Further, the above time lines will not be applicable for virgin territory i.e. locations where a new line needs to be laid beyond 500 meters from the nearest available source and where the requisition load is more than 200 KVA.

All the Superintending Engineer's O & M Circles/ EE's of O & M Divisions are requested to adhere to the above mentioned instructions scrupulously.
